Pre-contract Qualification for the Construction of Vincent Tshabalala Pedestrian Bridge

The Johannesburg Development Agency invites pre-qualification tenders for the construction of Vincent Tshabalala Pedestrian Bridge, pedestrian walkways, bridge lighting and street furniture provision, as well as soft and hard landscaping around the bridge. The pre-qualification is intended to obtain a shortlist of competent contractors who will contest the financial tender in a closed bid.

The successful tenderer will be expected to manage the component of the emerging subcontractors who will be responsible for executing the portions of the work.

It is estimated that each tenderer should have a CIDB Contractor grading designation of 7CE PE or higher. Registered contractors will be eligible to tender.

Joint ventures are eligible to submit tenders, provided that they satisfy criteria stated in the Tender Data.

Documents may be collected Monday to Friday between 08:00 and 17:00 from Monday, 12 June 2017.
