1. INTRODUCTION

Johannesburg Development Agency (JDA) is responsible for the management and operations of a portion of the Newtown Precinct. The functionality of the precinct including its cultural programmes and events require a clean, safe and secure environment to improve use of space for recreational purposes.

The service provider is required to provide cleaning services primarily but not limited to Mary Fitzgerald Square and Newtown Precinct Park as well as the peripheries of these City owned sites. Due to the current COVID-19 pandemic JDA requires all bidders to ensure PPE compliance, be a registered and valid member of any regulatory bodies for cleaning in South Africa such as the National Cleaning Association of South Africa (NCCA) and BEECA to name few accreditation will be required for the duration of the contract. Tenderers are to note that it is an explicit condition of this tender that all unskilled and general labourers are to be employed from the local community. It is also a condition of this tender that the successful service provider is required to sub-contract a minimum value of work to local SMME's / Co-operatives / Co-operatives equal to 30% of the contract sum within Region F ward 60.



3.8. Notes

- **3.8.1.** Tenderers must ensure that the final TOTAL FEE (A + B) is correctly carried to the "offer" page. The value recorded on the offer page will be regarded as the tendered amount to render services for the complete project period. Failing to price as required per item 3 above will result in the tender being disqualified.
- **3.8.2.** Fees must include standard disbursements such as typing, drawings, reproduction, copying, binding of documents, telephonic / electronic and facsimile communications, courier, local travel and accommodation, etc.

3.9. PROCUREMNET

3.9.1 Requirements

The service provider shall be required to adopt labour based techniques throughout the full spectrum of the works with the provision that the Employers specific objectives regarding TIME & QUALITY are in no way compromised.

Together with their tenders, all Tenderers are required to submit a comprehensive implementation plan clearly stating the labour content & number of job (s) opportunities that shall be created.

The employment of labour shall be reflected in a programme with sufficient detail to enable the Area Based Management and Place Making Coordinator to monitor and compare it with the implementation plan.

Tenderers are to note that it is an explicit condition of this tender that all unskilled and general labourers are to be employed from the local community. It is also a condition of this tender that the successful service provider is required to sub-contract a minimum value of work to local SMME's / Co-operatives / co-operatives equal to 30% of the contract sum. Such work must be clearly identified in the operational plan which must be provided by the successful bidder. Furthermore, it is a condition of this tender that the successful service provider is required to take full responsibility of managing all appointments, empowerment and overall quality of work delivered.

The service provider shall in general, **maximize the involvement of the local community.** This target applies to the service provider labourers and local labourers.

 The service provider shall be required to submit employment and SMME / Cooperatives data on a monthly basis to the Area Based Management and Place Making Coordinator. The Service provider including local SMME's / Cooperatives / Cooperatives will be required to pay labour rates which are in accordance with the department of Labour and including any future annual inflation adjustments. Service provider to provide a payment schedule for the Labour:

Payment 1 – for the SMME to pay suppliers for material/plant, subject to the necessary proof being furnished;
Payment 2 – for SMME's / Co-operatives to pay labourers employed, subject to the necessary proof being furnished and upon receipt of proof of payment of suppliers;

•Payment 3 – for any balance due based on a valuation done of works completed, upon receipt of proof of payment of labour. The service provider will be expected to pay SMME's / Co-operatives / Co-operatives full rates as submitted by the service provider to

Above this, it is a condition of this contract that should the service provider fail to pay the SMME's / Cooperatives with no valid reason/s, the JDA reserves the right to pay the SMME's / Co-operatives directly and deduct same from any amount paid to the service provider.

It is to be specifically noted that the rates for items of work to be executed by SMME's / Co-operatives must be market related. Tenderers are to ensure that rates tendered for this portion of the works is to take into account all items that the main service provider would have allowed for in his normal course of pricing, i.e. materials, labour, wastage, profit, attendance, etc. all at applicable productivity rates.

- 2. The Service provider is to generate monthly reports for the JDA that includes the following:
 - a) SMME / Co-operatives resources on the site, i.e. supervisors, labour and equipment
 - b) SMME / Co-operatives progress of works on site.
 - c) Copies of minutes of the SMME's / Co-operatives and Service provider progress meetings.
 - d) Concerns and improvements to be made.

The Tenderers are to price the works to achieve full compliance with the above requirements. Tenderers are to ensure that they allocate a dedicated individual to manage the SMME's / Co-operatives and fulfil the requirements stated above. Failure of the Service provider to achieve these requirements may result in the JDA enforcing compliance by appointing 3rd parties if necessary to assist and deducting all reasonable costs for achieving compliance from money due to the Service provider

The SMME's / Co-operatives to be contracted on the project must be selected from a database which will be issued to the appointed service provider on the commencement date of the contract. The data base will include for SMME's / Co-operatives that are youth, women owned, disabled and ex-combats. The service provider will be expected to give preference to SMME's / Co-operatives that comply with all/most of these groups.

The following information must be provided by said service provider within 14 days of the commencement date of the contract.

- 1. Detailed approach and methodology on the employment of local SMME's / Co-operatives
- 2. SMME's/ Co-operatives company name/s to be employed on the project.
- 3. SMME's / Co-operatives contact persons

- Failure to (i) replicate the tables under sections 3.5, (ii) carry the total to the offer page, and (iii) provide a detailed fee proposal (which indicates ALL items (a) to (d) above) will result in the tender being disqualified for non-compliance. Fees based on an hourly rate will NOT be compliant.

Tenderers will have to adhere to the compliance items above in order to be considered further in the evaluation process.

5.3. Price and Empowerment

Having completed a technical evaluation, the procedure for the evaluation of technically qualifying tenders is Method 2 (Price and Preferences). The Preference Point System assigns a score to each tenderer based on the tender price and on the tenderer's BBBEE status. These scores are combined to determine an overall score for the tender. The tender with the highest score will be considered for acceptance.

The Preference Point System will be applied as follows:

- ➢ For tenders up to R50 million
 - 80 points are assigned to price
 - Up to 20 points are assigned to BBBEE status per the table under item 7.3.1

- 6.3.1.1 "B-BBEE status level of contributor" means the B-BBEE status received by a measured entity based on its overall performance using the relevant scorecard contained in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act (Act No.53 of 2003).

- 6.3.1.7 A person will not be awarded points for B-BBEE status level if it is indicated in the tender documents that such a tenderer intends sub-contracting more than 25% of the value of the contract to any other enterprise that does not qualify for at least the points that such a tenderer qualifies for.

7. RISK TOLERANCE

The JDA has adopted a Risk Tolerance Framework (RTF) which enjoins the JDA to consider its risk exposure to service providers / service providers in terms of the number of contracts awarded to a single service provider / service provider in a particular year.

In terms of the Risk Tolerance Framework, the JDA determines the risk exposure as excessive in instances where the value of the contracts for **individual** professional service providers (e.g. project managers / engineers / quantity surveyors / consultants) is either:

- 1. The greater of R8 million or four contracts / projects in the current financial year or
- 2. The greater of R12 million or six contracts / projects over two financial years (current year and previous financial year)

And in instances where the value of contracts for **multi-disciplinary** professional service providers (e.g. more than one discipline / service is provided by the same bidder) is either:

- 3. The greater of R12 million or six contracts / projects in the current financial year or
- 4. The greater of R20 million or nine contracts / projects over two financial years (current year and previous financial year)

A risk analysis shall be undertaken on the bidder with the highest number of points obtained, to determine whether the tenderer does not exceed the JDA's risk framework criteria as stated above. In other words, whether it falls within the ambit of the Risk Tolerance Framework as acceptable.
