REQUEST FOR FORMAL WRITTEN PRICE QUOTATIONS: GEOTECH SERVICES AT LEHAE LIBRARY

1. INTRODUCTION

The JDA is requesting proposals from interested and qualified Geotechnical Service provider who is registered with the Engineering Council of South Africa (ECSA) and SANAS registered Geotechnical laboratories for an in-depth Geotechnical and dolomite stability Investigation survey Services for the implementation of the Lehae Multi-Purpose Centre Project for a period of 36 Months (March 2021 – March 2024).

There is a geotechnical engineering survey that was completed (+/- 3 years) for the construction of the recently built Lehae Library that had indicated there is a dolomitic material and further specialist investigations are required prior to the design and construction of the new multi-purpose center adjacent to the library.

2. SCOPE OF WORK AND DELIVERABLES

The Site Development Plan of Lehae Community facilities as well as construction thereof comprising the following but not limited to: - Estimated at 60m (Currently in Design/Tender stage)

- Construction of Building structures (Community Hall, Administration buildings & Offices etc.)
- Construction of parking areas, walkways, landscaping, lighting and fencing.
- Construction of multi-purpose indoor/outdoor courts, swimming pool.
- Construction of grandstand.

Johannesburg Development Agency ("JDA") requires the services of Engineering Council of South African (ECSA) registered companies (service provider) and or are SANAS registered Geotechnical laboratories to render an **in-depth Geotechnical and dolomite stability Investigation survey services**.

The Geotechnical Engineering Survey Consultant is required to be registered or familiar with acts and code of conduct of an appropriate professional body (i.e., ECSA/Geoscience), and to have the relevant professional accreditation (i.e. registered as Pr. or Pr. Tech Eng./SANAS), skills, experience and capacity to deliver the scope of work within the required time frame.

The Geotechnical Engineering Survey Consultant will be responsible for the survey that will assist the consultant with the design.

THE DETAILED GEOTECHNICAL ENGINEERING SURVEY WILL BE CARRIED OUT AS PER THE FOLLOWING SCOPE OF WORKS:

The scope of the proposed engagement is to provide geotechnical investigation and dolomite stability investigation services for the construction of Lehae Multi-Purpose Centre Project in the City of Johannesburg, in Gauteng province Region G.

All work under this contract should be executed in accordance to relevant SANS Codes and to TMH 1: 1986 – Standard Methods of Testing Road Construction Materials, issued by the Committee of State Road Authorities.

The Geotechnical investigation will form part of the inputs of the detail design. The detailed geotechnical investigation and dolomite stability investigation soil tests will be carried out as per the following scope of works:

- 1. A desk study of available information
- 2. Dolomite stability investigation including the following: Gravimetric Survey and Percussion Borehole Drilling
- 3. The geotechnical investigation must include trial holes and laboratory testing
 - Minimum 12 No. hand excavated inspection pits need to be excavated to a depth of 1m, there after pits needs to be extended using hand auger to a depth of approximately 2.5m.
 The test pits to be positioned under various sections of the building.
 - Minimum 12 No. Dynamic Cone Penetrometer Light (DPL) test required to be conducted under various building sections to determine the geology accurately. DCP tests to be carried out to a depth of 15m unless refusal is encountered at a shallow depth.
 - The locations of the test pits on the site need to be mapped.
- 4. Determine the geology and the relevant mechanical properties of the soil and rock horizons present on the site.
- 5. Determine permeability of the soil.
- 6. Determine the stability of cutting and fills.
- 7. Hazard Classification (According to current standards with a color map of the site)
- 8. Construction Recommendations on
 - Possible rehabilitation methods of dolomitic material;
 - General foundation recommendations for the proposed development (single and double storey buildings).
 - Recommendations and comments on the excavation characteristics and possible uses of the materials underlying the site for installation of services as well as for use in layer works in paving and roads.
 - Precautionary measures
 - The locations of site for core drilling and approximate depths of drilling.
 - The stability of cuttings and fills.
- 9. Dolomite risk management strategy
- 10. Approvals and recommendations from the Council for Geoscience

Technical

The technical assessment is based on the criteria set-out below, failure to attach or submit the said documents will result in your submission being set aside.

The technical assessment is based on the criteria set-out below namely:

- 7.2.1 "B-BBEE status level of contributor" means the B-BBEE status received by a measured entity based on its overall performance using the relevant scorecard contained in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act (Act No.53 of 2003).
- 7.2.2 Tenderers must submit their original and valid B-BBEE status level verification certificate or a certified copy thereof, substantiating their B-BBEE rating. Certificates issued by either verification agencies accredited by the South African Accreditation System (SANAS) or by registered auditors approved by the Independent Regulatory Board for Auditors (IRBA) are acceptable.
- 7.2.3 An EME must submit a sworn affidavit confirming the following:
 - Annual Turnover Revenue of R10 million or less; and
 - Level of Black ownership
 - Any misrepresentation in terms of bullet point above constitutes a criminal offence as set out in the B-BBEE Act as amended.
- 7.2.4 The submission of such certificates must comply with the requirements of instructions and guidelines issued by the National Treasury and be in accordance with notices published by the Department of Trade and Industry in the Government Gazette.
- 7.2.5 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.
- 7.2.6 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate tender.
- 7.2.7 A person will not be awarded points for B-BBEE status level if it is indicated in the tender documents that such a tenderer intends sub-contracting more than 25% of the value of the contract to any other enterprise that does not qualify for at least the points that such a tenderer qualifies for.

7.2.8 A person awarded a contract will not be permitted to sub-contract more than 25% of the value of the contract to any other enterprise that does not have an equal or higher B-BBEE status level than the person concerned.

7.3 Price and Empowerment

Having completed a technical evaluation, the procedure for the evaluation of technically qualifying tenders is Method 2 (Price and Preferences). The Preference Point System assigns a score to each tenderer based on the tender price and on the tenderer's BBBEE status. These scores are combined to determine an overall score for the tender. The tender with the highest score will be considered for acceptance.

The Preference Point System will be applied as follows:

- 80 points are assigned to price
- Up to 20 points are assigned to BBBEE status per the table under item 7.2

The total preference points for a tender are calculated with the formula

PP = Ps + Pbee Where

PP is the total number of preference points scored by the tenderer **P**s is the points scored for the comparative price of the tenderer, and Pbee is the number of points awarded to the tenderer based on his certified B-BBEE status level
