

Professional suppliers are requested to quote for the supply and delivery of fifteen (15) portable two-way handheld radios which will be utilized by the Newtown Improvement District security personal daily, working day and night shift seven days a week.

4.1. Notes

- 1. Bidders MUST replicate the table ABOVE and submit as part of their detailed fee proposal [which proposal must show pricing as requested for each of the items], per year and the TOTAL FEE must be carried to the "Offer" page.
- 2. Bidders MUST Complete pricing schedule or will be disqualified
- 3. Bidders MUST ensure that the final TOTAL FEE is correctly carried to the "offer" page. The value recorded on the offer page will be regarded as the tendered amount. Failing to price as required will result in the tender being disqualified.
- 4. A Tax Clearance Certificate and/or Tax Pin Number. Bidder's whose tax matters are not in order with the South African Receiver of Revenue at time of appointment will be disqualified.
- 5. All values are subject to change (increase or decrease) depending on the requirements of the project. However, the fee calculation submitted by the Bidders on tendering will determine the fees due for the duration of contract.
- 6. Fees must be inclusive of any foreseen price increases or escalations.
- 7. Fees must include standard disbursements such as typing, drawings, reproduction, copying, binding of documents, telephonic/electronic and facsimile communications, courier, local travel and accommodation, etc.
- 8. Successful Bidders will be remunerated in accordance with JDA's Standard Form Agreement which will be provided on point of award.
- 9. Successful Bidder is required to provide a 12-month warranty.

5. PROPOSAL CONTENT

The bidder's submission must provide the JDA with sufficient information to enable the employer to make a sound and fair evaluation of the proposal. The proposal should <u>use the same item numbers as below. using numbered dividers</u>.

The following minimum documentation must be provided:

- 5.1 THE "OFFER" PAGE MUST BE COMPLETED IN FULL AND SIGNED. Any bidder who fails to do so will be disqualified.
- 5.2 Service providers/suppliers are required to submit a detailed fee proposal based on the requirements set out in item 4 above and to ensure that the final TOTAL FEE IS CORRECTLY TRANSFERRED TO THE "OFFER" PAGE. Any bidder who fails to do so will be disqualified.
- 5.3 A valid BBBEE status level verification certificate substantiating the bidding entities BBBEE rating. Only certificates issued by verification agencies accredited by the South African Accreditation System (SANAS), or by registered auditors approved by the Independent Regulatory Board of Auditors (IRBA) will be

accepted. IF A COPY IS SUBMITTED IT MUST BEAR AN ORIGINAL CERTIFICATION STAMP. FAILURE TO SUBMIT A BBBEE STATUS LEVEL CERTIFICATE WILL RESULT IN THE BIDDER SCORING ZERO (0) POINTS FOR BBBEE.

An Exempted Micro Enterprises (EME) must submit a sworn affidavit confirming the following:

- Annual turnover revenue of R10 million or less; and
- Level of black ownership

Any misrepresentation in terms of the above constitutes a criminal offence as set out in the B-BBEE Act as amended.

- 5.4 Company registration documents.
- 5.5 A copy of the bidding entity's current municipal rates account in the name of the bidding entity or alternatively in the names of the directors / partners of the bidding entity. A lease agreement will also suffice
- 5.6 Audited financial statements for the past three financial years.
- 5.7 Details of directors / partners / members and shareholders with certified copies of their identity documents.
- 5.8 The forms A to G annexed, must be scrutinized, completed in full and submitted together with your quotation.
- 5.9 A corporate brochure alternatively a summary of the entity's background.

Note for consortium and joint ventures

6. ASSESSMENT CRITERIA

Submissions will be evaluated on the below criteria:

- Compliance
- Local content
- · Price / BBBEE
- Risk Tolerance

6.1 COMPLIANCE

Bidders will be disqualified in the following instances;

- If any of its directors are listed on the register of defaulters;
- In the case of a bidder who during the last five years has failed to perform satisfactorily on previous contracts with the JDA or any other organ of state after written notice was given to that bidder that performance was unsatisfactory;

- Bidders who did not complete, in full, the tender offer page (i.e. priced, all registration numbers provided and signed):
- Bidders whose tender document has been completed in pencil;
- Bidders whose document has been faxed;
- Bidders whose tender document has been received after the closing time
- > Bidders whose tender document has not been deposited in the tender box at the time of closing;
- Bidders who fail to price as required i.e. as stipulated in item 4 herein;
- > Bidders who did not comply with any other requirement as set out in the tender specifications;
- > Bidders who have any directors in the employment of the state.
- No award will be made to any bidder who is not registered on the National Treasury Central Supplier Database (CSD)
- No award will be made to any bidder whose tax matters are not in order with the receiver of revenue (SARS);
- No award will made if a bidder did not provide a 12 months warranty and a guarantee.

6.2 Local Content

Only bids with the stipulated minimum threshold of 60% (As per annexure G) for local production & content will be considered, failing to meet this, bid/s will be disqualified.

6.3 Price and Empowerment

Having completed a technical evaluation, the procedure for the evaluation of technically qualifying tenders is Method 2 (Price and Preferences). The Preference Point System assigns a score to each tenderer based on the tender price and on the tenderer's BBBEE status. These scores are combined to determine an overall score for the tender. The tender with the highest score will be considered for acceptance.

The Preference Point System will be applied as follows:

- For tenders up to R50 million
 - 80 points are assigned to price
 - Up to 20 points are assigned to BBBE status per the table under item 7.3.1
- Points scored will be rounded off to the nearest 2 decimal places

6.4 Points awarded for BBBEE status level

Points will be awarded for empowerment (BBBEE), in accordance with the Preferential Procurement Regulations 2017 published in Government Gazette No. 40553 dated 20 January 2017. The table overleaf is applicable in this regard:

- 6.4.1 "B-BBEE status level of contributor" means the B-BBEE status received by a measured entity based on its overall performance using the relevant scorecard contained in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act (Act No.53 of 2003).
- 6.4.2 Tenderers must submit their original and valid B-BBEE status level verification certificate or a certified copy thereof, substantiating their B-BBEE rating. Certificates issued by either verification agencies accredited by the South African Accreditation System (SANAS) or by registered auditors approved by the Independent Regulatory Board for Auditors (IRBA) are acceptable.
- 6.4.3 An EME must submit a sworn affidavit confirming the following:
 - Annual Turnover Revenue of R10 million or less; and
 - Level of Black ownership
 - Any misrepresentation in terms of bullet point above constitutes a criminal offence as set out in the B-BBEE Act as amended.
- The submission of such certificates must comply with the requirements of instructions and guidelines issued by the National Treasury and be in accordance with notices published by the Department of Trade and Industry in the Government Gazette.
- A trust, consortium or joint venture will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.
- 6.4.6 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate tender.
- A person will not be awarded points for B-BBEE status level if it is indicated in the tender documents that such a tenderer intends sub-contracting more than 25% of the value of the contract to any other enterprise that does not qualify for at least the points that such a tenderer qualifies for.
- 6.4.8 A person awarded a contract will not be permitted to sub-contract more than 25% of the value of the contract to any other enterprise that does not have an equal or higher B-BBEE status level than the person concerned.

6.5 Formula for scoring tender price

The following formula will be used to calculate the points for price.

 P_s = Points scored for comparative price of tender under consideration

 P_t = Comparative price of tender under consideration P_{min}

= Comparative price of lowest acceptable tender **X** = **Points**

The total preference points for a tender are calculated with the formula

$$PP = P_s + P_{bee}$$
 where

PP is the total number of preference points scored by the tenderer

Ps is the points scored for the comparative price of the tenderer, and

P_{bee} is the number of points awarded to the tenderer based on his certified B-BBEE status level.

7. Risk Tolerance

The JDA has adopted a Risk Tolerance Framework (RTF) which enjoins the JDA to consider its risk exposure to contractors / service providers in terms of the number of contracts awarded to a single contractor / service provider in a particular year.

In terms of the Risk Tolerance Framework, the JDA determines the risk exposure as excessive in instances where the value of the contracts for **individual** professional service providers (e.g. project managers / engineers / quantity surveyors / consultants) is either:

- 1. The greater of R8 million or four contracts / projects in the current financial year or
- 2. The greater of R12 million or six contracts / projects over two financial years (current year and previous financial year)

OR

And in instances where the value of contracts for **multi-disciplinary** professional service providers (egg. where more than one discipline / service is provided by the same bidder) is either:

- 3. The greater of R12 million or six contracts / projects in the current financial year or
- 4. The greater of R20 million or nine contracts / projects over two financial years (current year and previous financial year)

A risk analysis shall be undertaken on the bidder with the highest number of points obtained, to determine whether the tenderer does not exceed the JDA's risk framework criteria as stated above. In other words, whether it falls within the ambit of the Risk Tolerance Framework as acceptable.

JDA reserves the right to award a contract to a bidder who has exceeded the threshold as stated above.

8. COMPULSORY BRIEFING, CLOSING DATE, TIME AND VENUE FOR SUBMISSIONS
