1. Introduction

The wellbeing of JDA employees is very important in ensuring that they are fully engaged and function at their optimum levels while fulfilling the many roles they fill in their lives. To assist with supporting our organisation and employees' wide range of wellness needs the JDA is requesting proposals from experienced Employee Assistance/Wellness Programme service providers to render integrated EAP services to the JDA for a staff complement of around 96 employees and their loved ones.

2. Purpose

The Purpose of this Document is to define the Scope of the EAP services required for the Employee Wellness programme of the JDA.

3. Objective

The JDA is requesting proposals from experienced Employee Assistance/Wellness Programme service providers to render integrated EAP services to the JDA for a staff complement of around 96 employees and their loved ones.

This benefit will contribute to a happy, engaged and a productive workforce.

4. Project Deliverables

The EAP services must be comprehensive and address the complete integrated workplace wellness programme. The EAP services should be easily accessible to employees and their loved ones, cost effective as well as of the best quality, the service provider must implement best wellness management practices in all aspects of the service delivery. The following deliverables are expected but not limited to:

- Provide confidential professional counselling support services both telephonically and face to face consultations with registered professionals;
- 24/7 direct, unlimited and confidential first line access and assistance to multilingual, toll-free psychological, relationship, life management and general counselling service;
- Face-to-face counselling sessions with registered counsellors, psychologists, wellness
 practitioners for each person who are assisted via the EAP system at a time and place that is most
 suitable to them;
- Comprehensive trauma response services;
- Managerial consultancy and referral options supporting managers in their respective roles within the JDA in dealing with absenteeism, performance and/or wellness related challenges;
- Provide health and wellness education through up-to-date monthly newsletters with guidance on trending health issues and training programmes;
- Quarterly and Annual reports on all key utilisation aspects of the EAP;
- Advise and recommendations where necessary with regards to any interventions relating to prevention measures or wellness improvements where concerns are raised;
- Coordinate and manage the JDAs Wellness Day biannually (twice a year);
- · Conduct and provide assistance on Occupational Health assessment when required;
- Provide medical assistance support in the event of any medical intervention required such as chronic illness management;
- Provide financial management/wellness education and counselling when required;
- Provide legal advice when required;

The proposed EAP service provider must comply with the following:

- Have over 10 years of experience in the Workplace Health industry.
- Their network of counsellors and psychologists must be registered with the relevant Health Professional bodies as regulated.

 They should have a national footprint and/or network to ensure service is available to our employees and their loved ones at any time and place closer to their homes, place of work and/or anywhere when trauma support is needed.

- 5.1. Proof of end-to-end EAP Programme implementations that they have completed.
- 5.2. Completed similar projects in the past 5 years with contactable reference letters in a letter head of the client, with a bid description, the duration of the project, the value of project and must be signed.

Appointment

The Johannesburg Development Agency is requesting proposals from experienced Employee Assistance/Wellness Programme service providers to render integrated EAP services to the JDA for a staff complement of around 96 employees and their loved ones for a period of 36 months.

The bidders are to ensure that they have all the relevant skills (proposed key personnel), experience and capacity to deliver the scope of work within the required timelines.

6.1. Notes

6.1.1 Bidders are to ensure that they have adequate resources to undertake the work under stringent timeframes.

- 6.1.2 Bidders are required to ensure that project team leader has the leadership capacity and capability to independently handle and manage project challenges (if any) in order to ensure successful completion of the project. The team proposed must be the one executing the services.
- 6.1.3 The JDA reserves the right to ask tenderers to replace any member/s of the proposed team if they do not meet the JDA requirements.
- 6.1.4 Successful tenderers will be required to sign the JDA's Standard Form Agreement and appendices.
- 6.1.5 Bidders must note that they may be required to present final report to the JDA's Executive Corporate manager and the Senior Manager: HC Operations if deemed necessary.
- 6.1.6 Bidders must note that they will be required to provide weekly project progress reports to the Executive Corporate manager and the Senior Manager: HC Operations.
- 6.1.7 Bidders must also note that all documents and information gathered are to remain the property of JDA and should not be used or shared with any external party without prior consent by the Executive Corporate manager and the Senior Manager: HC Operations.
- 6.1.8 The bidder is to provide the indicated / required resources and corresponding cost that he/she proposes for the delivery on the project requirements.
- 6.1.9 The bidder is expected to include on the pricing for all the reasonable activities, and disbursements fees.

A bidder who fails to complete the Offer page and pricing table in full will be disqualified

Notes

- Any fee proposals must include for anticipated and standard disbursements which are to include typing, reproduction, copying, binding of documents, telephonic/electronic and facsimile communication, courier, local travel and any other cost for the client costs.
- The payment of fees will not exceed the apportionment amount per appointment letter.

- The amounts recorded on the offer page will be deemed to be the tendered amounts.
- Disputes shall be settled in good faith between parties in an effort to resolve the dispute. If the

7. PROPOSAL CONTENT

The bidder's submission must provide the JDA with sufficient information to enable JDA to make a sound and fair evaluation of the proposal.

It must clearly indicate the **relevant** previous experience, capability, and capacity of the bidding entity to undertake the project.

The proposal should <u>use the same item numbers as below</u>. The proposal must be clearly marked and indexed.

The following minimum documentation must be provided:

- 7.1 THE "OFFER" PAGE MUST BE COMPLETED IN FULL AND SIGNED. Any bidder who fails to do so will be disqualified.
- 7.2 Tenderers are required to submit a fee proposal based on the requirements set out in item 6 above and to ensure that the final TOTAL FEE IS CORRECTLY TRANSFERRED TO THE "OFFER" PAGE. Any bidder who fails to do so will be disqualified.
- 7.3 A valid / or certified BBBEE status level verification certificate substantiating the bidding entities BBBEE rating. Only certificates issued by verification agencies accredited by the South African Accreditation System (SANAS), or by registered auditors approved by the Independent Regulatory Board of Auditors (IRBA) will be accepted.

FAILURE TO SUBMIT A BBBEE STATUS LEVEL CERTIFICATE WILL RESULT IN THE BIDDER SCORING ZERO (0) POINTS FOR BBBEE.

OR

An EME must submit a sworn affidavit confirming the following:

- Annual turnover revenue of R10 million or less; and
- Level of black ownership

Any misrepresentation in terms of the above constitutes a criminal offence as set out in the B-BBEE Act as amended.

- 7.9 A detailed approach and methodology statement wherein the approach to be followed in each stage of the assessment process is outlined with clear identification of the deliverables.
- 7.10 This section should show the tenderer understands of the process, input required towards the completion of the required services and the expected outputs and outcomes.
- 7.11 The forms A to G annexed hereto, must be scrutinized, completed in full, signed and submitted together with your proposal.
- 7.12 A corporate brochure alternatively a brief summary of the entity's background.
- 7.13 Provide information on the individuals who will be assigned to **this project (NOT the entire company)**. The following **must** be addressed:
 - Organogram of the project team
 - > Role/s and responsibility/ies of the project team on this project

- > Relevant qualifications, professional registration (where required) and attach proof thereof
- Number of years of relevant experience in EAP Programme projects implementation services as a company
- Detailed CV's for each member of the team noting their specific relevant project experience [qualifications, role, membership certificates where applicable, Numbers of years of experience]
- Individual memberships to professional associations (where required) and attach proof hereof if available.
- ➤ The appointed bidder must bring to the JDA the same team proposed as per this tender document and failure to do so will result in the cancellation of the contract.

7.16 Note for joint ventures

- **EACH** party to a joint venture is to submit the requisite documents and / or information as requested in item 6 − 8.
- An Agreement or Heads of Terms recording the arrangement between the parties to the consortium / joint venture is to be submitted.
- A lead consultant is to be appointed and noted in the submission.
- A trust, consortium or joint venture will qualify for points for their BBBEE status level as an unincorporated entity, provided that the entity submits their consolidated BBBEE scorecard as if they were a group structure and that such a consolidated BBBEE scorecard is prepared for every separate tender.

Failure to comply with these conditions may invalidate your offer.

8. ASSESSMENT CRITERIA

Submissions will be evaluated on the criteria to follow:

- Compliance
- Technical
- Price / BBBEE
- · Risk Tolerance

8.1 Compliance

Bidders will be disqualified for the following cases:

- If any of its directors are listed on the National Treasury register of defaulters.
- A bidder who during the last five years has failed to perform satisfactorily on previous contracts with the JDA or any other organ of state after written notice was given to that bidder that performance was unsatisfactory. Or the contract was terminated.
- Who did not complete, in full, the tender offer page and pricing table (i.e., priced, all registration numbers provided and signed).
- Who failed to price as required i.e as stipulated in item 6 here in.
- Who's tender document has been completed in pencil.
- > Who's tender document has been faxed and or e-mailed.
- > Who directors are/is in the employment of the state.
- > Bidders whose tender document have been received after the closing date and time.
- Who did not comply with any other requirement as set out in the tender specifications
- No award will be made to any bidder who is not registered on the National Treasury Central Supplier Database (CSD).

8.2 Technical

The technical assessment is based on the criteria set out below namely:

- (a) Key Returnable Documents,
- (b) Capability of the Proposed Key Team Members (i.e., experience, qualifications,),
- (c) Company experience (i.e., EAP Programme projects, and references) and
- (d) Contactable references in line with item (c) above.

Note that duplication of resources/personnel on the designations indicated in the criteria will result in zero points being awarded for one criterion.

Tenderers will have to submit compliant documents and score a minimum number of points in the technical evaluation in order to be considered further in the evaluation process.

Total points = 184 and service providers are required to score a minimum (60%) which translate to of 110.4 points for them to proceed to the next phase of evaluation (price and bbbee).

8.3 Price and Empowerment

Having completed a technical evaluation, the procedure for the evaluation of technically qualifying tenders is Method 2 (Price and Preferences). The Preference Point System assigns a score to each tenderer based on the tender price and on the tenderer's BBBEE status.

These scores are combined to determine an overall score for the tender. The tender with the highest score will be considered for acceptance.

The Preference Point System will be applied as follows:

- ➤ For tenders up to R50 million
 - 80 points are assigned to price
 - Up to 20 points are assigned to BBBEE status per the table under item 8.
- > Points scored will be rounded off to the nearest 2 decimal places

8.3.1 Points awarded for BBBEE status level

Points will be awarded for empowerment (BBBEE), in accordance with the Preferential Procurement Regulations 2017 published in Government Gazette No. 40553 dated 20 January 2017. The table overleaf is applicable in this regard:

- 8.3.1.1 "B-BBEE status level of contributor" means the B-BBEE status received by a measured entity based on its overall performance using the relevant scorecard contained in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9.3 of the Broad-Based Black Economic Empowerment Act (Act No.53 of 2003).
- 8.3.1.2 Tenderers must submit their original and valid B-BBEE status level verification certificate substantiating their B-BBEE rating. Certificates issued by either verification agencies accredited by the South African Accreditation System (SANAS) or by registered auditors approved by the Independent Regulatory Board for Auditors (IRBA) are acceptable. FAILURE TO SUBMIT A BBBEE STATUS LEVEL CERTIFICATE WILL RESULT IN THE BIDDER SCORING ZERO (0) POINTS FOR BBBEE.
- 8.3.1.3 An EME must submit a sworn affidavit confirming the following:

- Annual Turnover Revenue of R10 million or less; and
- Level of Black ownership
- Any misrepresentation in terms of bullet point above constitutes a criminal offence as set out in the B-BBEE Act as amended.
- 8.3.1.4 The submission of such certificates must comply with the requirements of instructions and guidelines issued by the National Treasury and are in accordance with notices published by the Department of Trade and Industry in the Government Gazette.
- 8.3.1.5 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.
- 8.3.1.6 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate tender.
- 8.3.1.7 A person will not be awarded points for B-BBEE status level if it is indicated in the tender documents that such a tenderer intends sub-contracting more than 25% of the value of the contract to any other enterprise that does not qualify for at least the points that such a tenderer qualifies for.
- 8.3.1.8 A person awarded a contract will not be permitted to sub-contract more than 25% of the value of the contract to any other enterprise that does not have an equal or higher B-BBEE status level than the person concerned.
- 8.3.1.9 No tender will be awarded to a bidder whose tax matters are not in order with SARS.
- 8.3.1.10 No tender will be awarded to a bidder who is not registered on CSD.

8.3.2 Formula for scoring tender price

8.3.3 The total preference points for a tender are calculated with the formula

PP is the total number of preference points scored by the tenderer

Ps is the points scored for the comparative price of the tenderer, and

Pbee is the number of points awarded to the tenderer based on his certified B-BBEE status level

8.4 RISK TOLERANCE

The JDA has adopted a Risk Tolerance Framework (RTF) which enjoins the JDA to consider its risk exposure to contractors / service providers in terms of the number of contracts awarded to a single contractor / service provider in a particular year.

In terms of the Risk Tolerance Framework, the JDA determines the risk exposure as excessive in instances where the value of the contracts for individual professional service providers (e.g. project managers / engineers / quantity surveyors / consultants) is either:

The greater of R8 million or four contracts / projects in the current financial year or The greater of R12 million or six contracts / projects over two financial years (current year and previous financial year)

And in instances where the value of contracts for multi-disciplinary professional service providers (e.g. more than one discipline / service is provided by the same bidder) is either:

The greater of R12 million or six contracts / projects in the current financial year or The greater of R20 million or nine contracts / projects over two financial years (current year and previous financial year)

A risk analysis shall be undertaken on the bidder with the highest number of points obtained, to determine whether the tenderer does not exceed the JDA's risk framework criteria as stated above. In other words, whether it falls within the ambit of the Risk Tolerance Framework as acceptable.

JDA reserves the right to award a contract to a bidder who has exceeded the threshold as stated above
