1. INTRODUCTION

The Johannesburg Development Agency (JDA) is an area-based development agency of the City of Joburg. Much of the JDA's work is focused on strategic economic nodes and corridors, where we implement priority projects that align with the spatial transformation outcomes of the City of Joburg's Growth and Development Strategy and Spatial Development Frameworks.

The City of Johannesburg intends to eradicate dilapidated, hazardous, and unsafe buildings in the inner city. The JDA has been mandated to facilitate the demolishing of bad buildings while adhering to all the relevant statutory regulations. The equipment will be needed on an Ad hoc basis.

This project aligns with the City of Johannesburg's Inner City Regeneration Strategy.

1.1 Background

The JDA Offices are situated in the Bus Factory premises at 3 Helen Joseph Street, Newtown, Johannesburg.

The JDA requires to appoint a service provider for supply and delivery of power tools intended to be used to remove illegal outdoor advertisement signages as an when required. The City is experiencing mushrooming of Illegal billboards and advertising signage at all street corners and on street lights.

2. SPECIFICATION

The successful service provider expected to supply and delivery the following equipment

- 1) 1 x Portable 800watts Generator (Petrol)
- 2) 1 x Power cutting torch (Oxy fuel cutting torch)
- 3) 2 x 5 pounds Hammer (forged steel)
- 4) 2 x 4 -pound hammer (forged steel)
- 5) 1 x Jack Hammer (Pneumatic air powered) will a full set of drill bit
- 6) 2 x 50 meters of electric reel extension
- 7) 2 x Angel Grinder & cutting Discs(packs)
- 8) 2 x step ladders (foldable 15m-aluminium)
- 9) 4 x Side cutters/players
- 2x Bolt Cutters/Players (bigger sizes fit to cut big bolts that are used to fasten big poles from base plates of billboards)
- 11) 10 x welding hand gloves,
- 12) 10 x welding helmets,
- 13) 10 x welding googles.

3. NOTES FOR PRICING

The basis for fee proposals is outlined in item 3.1 below.

This is followed by item 6.1 which applicants are required to take note of.

3.1 Tenderers are to complete all the items on the pricing table below and submit as part of their fee proposal to transfer or carry over the total fee to the "Offer" page correctly.

Failure to complete in full the pricing table and price as required will result in the tender being disqualified for non-compliance.

3.2 <u>Notes</u>

- 3.2.1 Tenderers must ensure that the final <u>PRICING TABLE TOTAL FEE</u> is correctly carried over to the "offer" page. The total value recorded as total of pricing table must be the same as the one recorded on the offer page, which will be regarded as the quoted amount to render services. Failing to price as required will result in the RFQ submission being disqualified.
- 3.2.2 Fees <u>must</u> include standard disbursements such as typing, reproduction, copying, binding of documents, telephonic / electronic and facsimile communications, courier, local travel and accommodation, etc.
- 3.2.3 It is the responsibility of the bidder to ensure that they have a local office within the geographical area of City of Johannesburg as the JDA will not be responsible for accommodation and travelling costs.
- 3.2.4 That the RFQ is issued out in line with POPI Act.

- 3.2.6 Bidders are advised to quote on quality, durable and on correct quantities.

The total price to be correctly transferred to the offer page, and failure to do that, bidders will be disqualified including no quoting / pricing all item correctly.

4.1 PRESENTATION OF QUOTATIONS

Submissions are to consist of a short (**not to exceed 15 pages**) and comprehensible report that must provide the JDA with sufficient information to make a sound and fair evaluation of the quotation as well as the experience and capability of the applicant to undertake and manage the project successfully.

The report should **use the same item numbers as below** for the required sections of the report.

The following information must be clearly spelt out:

- <u>BRIEF</u> company background lists of SIMILAR (supply and delivery of office consumables and stationery) projects (including client name, contact person, telephone number, value of the project, and the consulting fee value, nature of the project, required deliverables).
- A copy of a valid SARS Tax Pin Compliant certificate. No award will be made to a service provider whose tax matters are not in order with the South African Revenue Services.
- No award will be made to a service provider who is not registered with National Treasury Central Supplier Database.
- A copy of the tenderer's latest municipal rates account in the name of the tenderer <u>or</u> alternatively in the names of the Directors / Partners of the tendering entity. Copies of lease agreements <u>will be accepted</u>.

- An original and valid BBBEE status levels verification certificate or a certified copy thereof, substantiating the bidding entities BBBEE rating. Only certificates issued by verification agencies accredited by the South African Accreditation System (SANAS), or by registered auditors approved by the Independent Regulatory Board of Auditors (IRBA) will be accepted. An EME must submit an affidavit confirming the following:
- Annual Turnover Revenue of R10 million or less; and
- Level of Black ownership
- Any misrepresentation in terms of bullet point above constitutes a criminal offence as set out in the B-BBEE Act as amended.
 - An original letter from the tenderer's bank confirming account information.
 - Bidders are required to submit detailed quotations based on the required deliverables defined in rand terms. Applicants are to illustrate the fee proposal linked to deliverables. All disbursements, etc. are to be included in the quotations.
 - A completed RFQ document with all sections filled in (references in the RFQ to other documentation attached will NOT be considered.)
 - The forms A to F annexed, must be scrutinized, completed in full and submitted together with your RFQ.

Failure to comply with the requirements in item 3 and 4 will result in tenderers been negatively scored for responsiveness or disqualified for non-compliance.

Note for consortium and joint ventures.

- The items above are to be addressed and completed by **EACH** member of the consortium or joint venture.
- An agreement between all parties of the consortium or joint venture is to accompany the tender submission.

- > Bidders whose quotation document has been completed in pencil;

5.3 Price and Preferential Goals

The 80/20 preference point system will apply to this tender and the lowest acceptable tender will be used to determine the applicable preference point system The 80/20 price/preference points system will be applied to the evaluation of responsive tenders up to and 20 including a Rand value of R50'000'000 (all applicable taxes included), whereby the order(s) will be placed with the tenderer(s) scoring the highest total number of adjudication points.

5.4 RISK TOLERANCE

The JDA has adopted a Risk Tolerance Framework (RTF) which enjoins the JDA to consider its risk exposure to contractors / service providers in terms of the number of contracts awarded to a single contractor / service provider in a particular year.

In terms of the Risk Tolerance Framework, the JDA determines the risk exposure as excessive in instances where the value of the contracts for individual professional service providers (eg. project managers / engineers / quantity surveyors / consultants) is either:

The greater of R8 million or four contracts / projects in the current financial year or The greater of R12 million or six contracts / projects over two financial years (current year and previous financial year)

And in instances where the value of contracts for multi-disciplinary professional service providers (eg. more than one discipline / service is provided by the same bidder) is either:

The greater of R12 million or six contracts / projects in the current financial year or The greater of R20 million or nine contracts / projects over two financial years (current year and previous financial year)

A risk analysis shall be undertaken on the bidder with the highest number of points obtained, to determine whether the tenderer does not exceed the JDA's risk framework criteria as stated above. In other words, whether it falls within the ambit of the Risk Tolerance Framework as acceptable.

JDA reserves the right to award a contract to a bidder who has exceeded the threshold as stated above.
