- **5.3** No award will be made to a service provider who is not registered with National Treasury Central Supplier Database.
- 5.4 A copy of the tenderer's latest municipal rates account in the name of the tenderer <u>or</u> alternatively in the names of the Directors / Partners of the tendering entity. Copies of lease agreements <u>will be accepted</u>.
